



# Emerging Producer Placement Program

**Program Guidelines** 

# About the program

The Emerging Producer Placement Program is an opportunity for emerging producers to gain fast-tracked experience working at both Screen NSW and local production companies.

Screen NSW is looking for the next wave of emerging producers.

The Emerging Producer Placement Program will provide emerging producers with a paid placement opportunity to gain unique experience. Firstly, by working alongside the Screen NSW Sector Investment team, and then with NSW screen production companies. This is a fast-track career opportunity that matches highly experienced screen industry practitioners with undiscovered emerging production talent.

Up to three placements will be offered in the 2025/26 round.

The first placement will begin in early 2026 with the dates to be mutually agreed by both parties. The additional placements will begin later in 2026.

Participants spend 52 days (usually 4 days per week/13 weeks) at Screen NSW and 52 days (usually 4 days per week/13 weeks) at a NSW production company.

The entire placement (including the period at the production company) must be completed within 12 months of commencement at Screen NSW.

# **Program objectives**

The objectives of the program are to:

- Provide access to the screen industry for NSW-based emerging producers
- Support the employment and development of sustainable career pathways for NSW-based screen producers
- Contribute to the growth and sustainability of a vibrant and accessible screen industry.

# Eligibility

## Who can apply

You must fulfil the following eligibility requirements:

- Be an emerging producer who currently resides in NSW.
- Identify from one or more of the following NSW Government key priority areas:
  - o Regional NSW
  - Western Sydney
  - First Nations people
  - o People from culturally and linguistically diverse backgrounds
  - o People living with disability
  - LGBTQIA+ people.
- Meet one of the following experience criteria:
  - Have at least one credit as producer on a short film or web series that has screened at one of the festivals on our Eligible Festival List (see Appendix A), OR
  - Have at least 5 years' experience in the screen industry including having worked with an established production company and/or market player (broadcaster, streamer, distributor etc) in a relevant role.

Priority for one placement will be reserved for an emerging First Nations producer.

Applicants must also adhere to the general eligible requirements under the Screen NSW <u>Terms</u> of Trade.





#### Who cannot apply

You are not eligible to apply if:

- You are a full-time student
- You are an established producer with 3 or more screen credits.

#### How do I apply?

You will need to complete an online expression of interest detailing how you meet the Selection Criteria and why you believe the attachment would be of value to you at this point in your career.

### Selection criteria

All applications are assessed against a common set of five criteria.

Successful applicants will show:

- A demonstrated understanding of production budgets (15%)
- Highly developed organisational skills and the ability to meet deadlines (20%)
- Analytical and research skills, and the ability to collate information and write reports using a variety of software packages (20%)
- An ability to work independently and to exercise initiative, sensitivity and discretion (20%)
- A knowledge of current development and project financing practices within Australia (25%).

# **Assessment process**

Once your application has been submitted, you will receive an email confirmation from our secure online grants system, SmartyGrants.

Late application requests will be reviewed and eligibility determined with absolute discretion by the Industry and Audience Development Manager, Screen NSW. You must lodge a request for a late application by email to <a href="mailto:industry@screen.nsw.gov.au">industry@screen.nsw.gov.au</a> setting out the reasons for the request, along with any evidence, by 3pm on the day applications close.

Applications will be assessed for eligibility, and a longlist will be provided to a panel of Screen NSW staff for assessment, including the Industry and Audience Development Manager and a representative from the Sector Investment team (Screen). Shortlisted applicants will be invited to interview, and subsequent recommendations will be considered by the Head of Screen NSW.

Your application will be assessed on your experience and expression of interest relating to the selection criteria.





Successful applicants will be notified via email by 1 December 2025.

#### When will the placement start?

The first placement will begin in early 2026 with the dates to be mutually agreed by both parties. The additional placements will begin later in 2026.

The entire placement (including the period at the production company) must be completed within 12 months of commencement at Screen NSW.

#### What happens if my application is shortlisted?

You will be notified by email, along with an interview invitation.

#### What happens if my application is not shortlisted?

You will be notified of your unsuccessful application by 1 December 2025 via email.
